## KC Cottrell entered business partnership with Environment & Energy Co., Ltd

On August 14, KC Cottrell signed the business partnership agreement with Environment & Energy Co., Ltd regarding Valve Type RTO (Regenerative Thermal Oxidizer, thermal storage type combustion device).

The RTO system is a VOC (Volatile Organic Compounds) reduction system that penetrates gas with VOC through the thermal storage room or combustible room and annihilates VOC gas at more than 800°C to discharge clean gas. KC Cottrell has been conferred the patent right from Environment & Energy Co., Ltd and entered business partnership earnestly on the valve type RTO technology, which is ultra-high efficiency system whose VOC processing efficiency reaches up to 99.5% among the RTO systems.

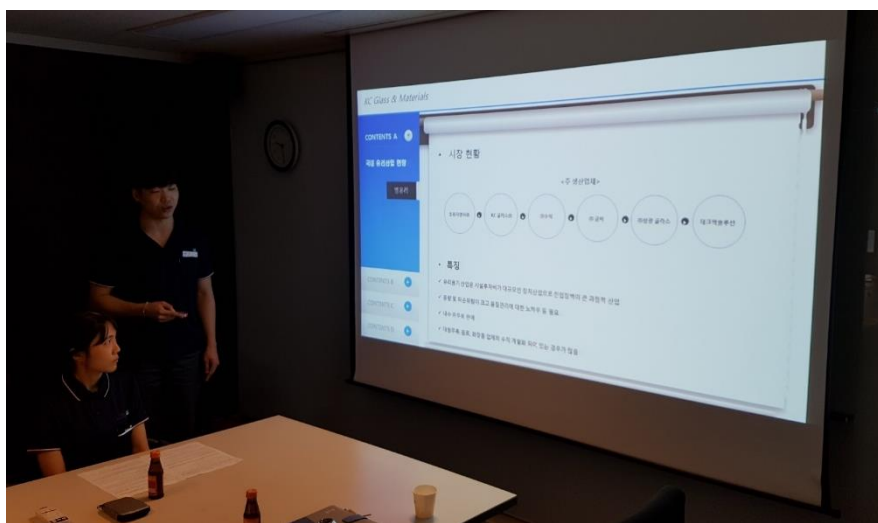
KC Cottrell gains momentum to expand VOC/ odor business as new businesses through this business partnership.

## 2. 2018 KC Glass & Materials summer internship program completion ceremony

KC Glass & Materials carried out 2018 summer internship program in order to provide work experiences to students waiting for graduation and employment and to discover key personnel earlier. Conducted for 7 weeks from July 9 to August 24, 2 products recommended from universities (Hong Ji-min, Kim Go-un) participated in the internship.

Through the introductory education for 3 days, the internship employees developed their understanding on eco-friendly manufacturing industry and company overview followed by the deployment to safety management of SEQ and quality management part respectively. Under the guidance of the chief Hwang Tae-seon, a dedicated mentor, they had field practices while supporting major related works and also carried out a survey research on the joint research project and individual project to be presented at time of closure of the internship. On August 24, when the 7-weeks internship program was complete, the presented project results, took feedback and received the internship program completion certificate while Kim Jeong-wan, CEO, Lee Seok-goo, vice-president and related officers and employees attended. The internship employees expressed their gratitude stating that “we could know the beautiful culture of KC Glass & Materials considering and cooperating between the management and the labor. ## Clestra Hauserman, obtained GGGI project



Last August 29<sup>th</sup>, Clestra Hauserman obtained GGGI (Global Green Growth Institute) project. GGGI where Ban Ki-mun, the former UN secretary of General is the chairman of the assembly and board of directors, is an international institute that provides a green growth model for developing countries for the sustainable economic development. In this project, Clestra Hauserman suggested eco-friendly interior space with the value of that institute according to the GREEN (ecological, natuRal, renEwable, efficiEnt, sustaiNable) concept.

Besides the interior, the project aims to receive LEED Certification, an eco-friendly certification system. For this purpose, Clestra Hauserman's M1 partition that contributes to LEED will be applied. In addition, phone booth (Fizz box) of Clestra Hauserman will be installed so that private spaces can be used in the open office. It will be completed by the end of October.
