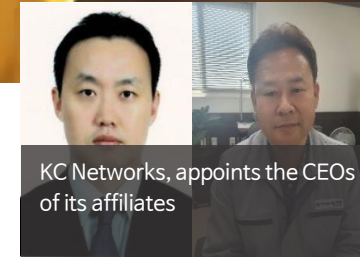

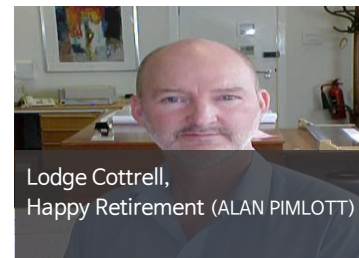

On January 4, KC Green Holdings had an untact kick-off meeting for the year 2021 through a video conference system.

Seongju Biochips, signs a MOU with Cheongju National Forestry Cooperative Federation



On January 14, 2021, Seongju Biochips signed a memorandum of business (MOU) with Cheongju National Forestry Cooperative Federation. According to the MOU, the two parties concluded a “main contract (joint project contract)” on March 17 and embarked on a joint project on April 1 in an about 6,400-pyeong site located in 407, Chujeong-ri, Nangseong-myeon, Sangdang-gu, Cheongju-shi.

According to the agreement, the National Forestry Cooperative Federation will procure materials and Seongju Biochips will process the procured materials and supply products. With this as a momentum, the company has gained a foothold to maximize the use of forest resources by not only making use of unused forest biomass, but also expanding its business into other areas, such as the recycling of waste wood, going forward.

At the moment, woodchips produced by Seongju Biochips are generating revenues through their supply to market players such as Donghae Coal-Fired Power Plant and Shinyoung E&P (SY Energy).



With this agreement, Seongju Biochips is likely to contribute to the development of ecofriendly energy businesses through the utilization of forestry resources that are either thrown away or abandoned. (end)

KC Cottrell, appointed as a preferred bidder for repairing environmental systems of Taiwan's thermoelectric power plant units 5-10



On March 25, 2021, KC Cottrell was selected as a preferred bidder in a bid notified by Taiwan Powder Company for a repair project on the environmental facilities of Taichung Power Plant Units 5 to 10.

This is a construction project aimed at improving the air quality control systems (AQCS) of six 550 MW coal-fired power plants (units 5 to 10), which includes denitrification, desulfurization, and water dust collection systems, as well as gas heat exchangers. It is a turnkey project that encompasses design, purchase, and installation.

This project is worth approximately 463.6 billion won based on the exchange rate on the day when preferred bidders were selected. This amounts to 141% of KC Cottrell's total electricity-based sales and will be recorded as KC Cottrell's largest project since its inception.

This project will be conducted for about four years from the date of signing the contract to May 2025. Following the selection of KC Cottrell as a preferred bidder, we expect the company to become a global leader in the field of air environment systems by concluding the main contract and executing the project successfully. KC Green Holdings, hosts the 48th regular general meeting of shareholders



On March 29, KC Green Holdings held the 48th regular general meeting of shareholders on the 11th floor of its head office in Sangam-dong, Seoul.

This meeting dealt with three reporting items for the company's 2020 business year (audit reporting, sales reporting, and reporting on operations of the internal financial management system) and five matters for decision (approval of financial and consolidated financial statements, a partial amendment of the articles of association, the appointment of board directors, director compensation limits, and auditor compensation limits).

KC Green Holdings introduced an electronic voting system so that shareholders would be able to exercise their shareholder and voting rights even without attending the meeting of shareholders. As a result, they were able to vote electronically from 9:00 am on March 19 to 5:00 pm on March 28.

CEO Taeyoung Lee said, "With internal and external factors such as the enforcement of the Act on Punishment for Serious Accidents and the 3 Fair Economy Act and the inauguration of the Biden administration in the US, the uncertainty of our business environment will likely continue in 2021." He added, "These factors, coupled with the wave of the fourth industrial revolution that has accelerated since the COVID-19 outbreak, will become a major turning point for our company".

He then noted, "At a time when we have to prepare for the post-coronavirus era, we will focus on the reorganization of portfolios, the spread and implementation of sustainable management, and the establishment of a healthy KC culture, which have been our mid- and long-term tasks".

Meanwhile, KC Green Holdings was fully committed to ensuring the safety and health of shareholders during the regular meeting of shareholders with more tightened COVID-19 quarantine measures than last year. (end)

On March 29, 2021, KC Cottrell hosted the 11th regular general meeting of shareholders on the 11th floor of its head office in Sangam-dong, Seoul. At this regular general meeting of shareholders, a total five matters for decision were presented along with reporting items such as audits, sales, and the current operations of the internal financial management system for KC Cottrell's 2020 business year.

KC Cottrell presented a plan for amending the articles of association with a focus on an overhaul of the regulations on the record date of dividend payout according to the amended Commercial Act, additional incorporation of the matters related to the registration of private loans under the Electronic Securities Act, and the application of amended regulations on the appointment of executives in the KC companies. The original agendas were approved during the meeting.

KC Cottrell also introduced an agenda on the appointment of executive directors and gained approval. As a result, president Jongkyoo Kim and managing director Kunhyun Na of KC Cottrell were newly appointed as inside executive directors.

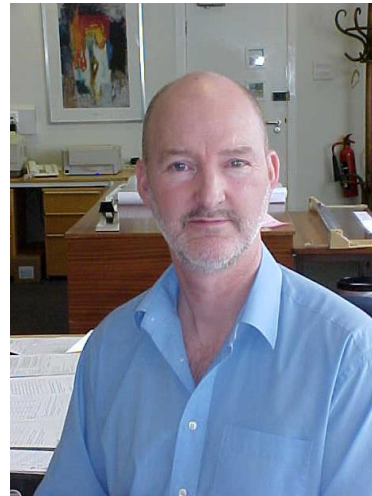

Rights to take an annual leave freely

In recent years, startups and some companies pursuing an innovative corporate culture have allowed employees to take their paid annual leave without entering the reason of annual leave in the application form by removing the respective section or even obtaining corporate approval. The intention behind this move is that companies do not necessarily need to know about or permit the annual leave of their workers, which is their legitimate right.

On other hand, some companies still make it difficult for workers to use their annual leave by limiting the number of days to take off or asking about detailed reasons for annual leave.

Annual leave is not a company's favor to its employees. It is a legal **right**¹⁾ entitled to workers, and the Ministry of Employment and Labor defines a company's act of forcing its employees not to take a annual leave without a valid reason as workplace harassment.

Certainly, a company's members should show responsible attitudes such as ensuring no disturbance in the company's smooth operation or seeking understanding in advance when they inevitably take an annual leave despite its interference with the company's operation.



What about making stepwise changes to create a healthy organizational culture based on trust between the company and its personnel by companies creating an atmosphere where their employees can take an annual leave freely and employees working responsibly. (end)

1) According to Article 60 of the Labor Standards Act, businesses should provide 15 days of paid annual leave to their employees who have worked for at least 80% of the working days in the previous year.

Now is time to reduce disposable items

1. Buried issue: Regulations on the use of disposable (plastic) items

The unexpected COVID-19 outbreak has changed our lives, and unlike the public expectation that it would end in a foreseeable future, the situation has been prolonged, leading to delays in the enforcement of important environmental regulations set to be enforced promptly.

In 2019, numerous countries poured out specific plans on how much they would reduce disposable items, and the Ministry of Environment also mapped out a plan to cut down the consumption of disposable goods by over 35% in 2022.

However, the pandemic has fostered the notion among individuals that disposable items are relatively safer. For this reason, restaurants are serving disposable packaged dishes and cafes are offering disposable cups instead of mugs. Consumers also prefer disposable products by reason of personal hygiene while opting for online shopping malls and delivery food, and in doing so, have gradually overlooked environmental damage.

2. Are disposable items really safe?

According to the data from the University of California at Los Angeles, USA, the COVID-19 virus stays in plastic and stainless materials for a couple of days and on the surface of paper for 24 hours. Therefore, while the virus can be detected from every surface, plastic is the material in which the virus can last for the longest hours. Because disposable items are not washed before use, non-disposable containers that have been washed and sterilized are safer than disposable ones.



3. Individuals making efforts to reduce disposable items

① Greenpeace Korea #Take Yonggi (Brave/Container) Campaign

In April of last year, actor Junyeol Ryu, a supporter of Greenpeace Korea, posted a photo of the items that he had bought at grocery stores on Instagram with the line "I have never bought you #Plastic" and received over 200,000 likes and over 1,800 comments.

Greenpeace Korea mentioned about the problem of disposable packages that are unnecessarily attached when you do grocery shopping, and launched the #Take Yonggi (Brave/Container) campaign that encourages individuals to put products in their personal containers. As part of its success, Lotte Mart, one of Korea's top 5 marts, also made "a declaration for a 50% reduction in the consumption of plastics within its outlets by 2025".

※ In Korean, "Yonggi" is a homophonic term, which has two meaning : 'brave' and 'container'. This campaign means "Take a brave and give your container."

② A 100-day experiment on waste reductions by Cheongju citizens

The Cheongju Upcycle Citizen Center conducted 'a 100-day experiment on waste reductions' with Cheongju citizens. The citizens who checked the amount of their waste themselves began to change their consumption habits using such methods as using non-disposable containers during food packaging and recording the amount of various types of garbage generated in everyday life. In one month after the start of the experiment, the total amount of wastes fell by 305 kg, and a citizen managed to reduce living expenses by 600,000 won in return for cutting down on consumption to reduce wastes.

If we do not change our lifestyles in the current era of climate crises, the global temperature will rise by 1.5 degrees in 2040, a threshold set by scientists. Using a disposable plastic item takes five minutes, but its decomposition takes 500 years. The climate crisis caused by humans can only be solved by humans, which therefore requires each individual's deep awareness and active endeavor. (end)
